The Tonto National Forest, an administrative unit of the U.S. Department of Agriculture, Forest Service, prepared a draft Environmental Impact Statement (EIS) to evaluate and disclose the potential environmental effects from approval of the preliminary mining plan of operations submitted by Pinto Valley Mining Corp. for the Pinto Valley Mine. The Pinto Valley Mine is an existing open pit copper and molybdenum mine located in Gila County, Arizona, approximately 8 miles west of the Town of Miami. the Town of Miami.

Pinto Valley Mining Corp. proposes to expand mining activities onto the Tonto National Forest, to extend the mine life to 2039, onto the Tonto National Forest, to extend the mine life to 2039, and to consolidate previous and ongoing authorizations for the mine. The Forest Service must process Pinto Valley Mining Corp's proposed mining plan of operations in accordance with Title 36, Part 228.5(a) of the Code of Federal Regulations (36 CFR 228.5(a)) and comply with regulations governing the use of surface resources in conjunction with the proposed mining operations on National Forest System lands. The Forest Service will determine whether to approve the mining plan of operations as submitted, or with changes or additions determined necessary to satisfy applicable regulations. The public scoping process identified air quality, biological resources, landscape productivity, cultural resources, recreation, social and economic conditions, geotechnical stability, and water resources as key issues for analysis. A notice of availability for the Pinto Valley Mine draft EIS was published in the Federal Register on December 13, 2019.
